4.1. Description of first aid measures

General information

4.2. Most important symptoms and effects, both acute and delayed

Following eye contact: Risk of serious damage to eyes. After skin contact: The product develops an alkaline pH value with moisture and can cause irritation. Contains chromium (VI). May produce an allergic reaction.

Following inhalation: Inhalation of dust may cause irritation of the respiratory system.

4.3. Indication of any immediate medical attention and special treatment needed
